

AGREEMENT for CiRA Research Internship Program

In the event that the student, _____ (“***Student***”), participates in CiRA Research Internship Program hosting by Center for iPS Cell Research and Application (“***CiRA***”) in Kyoto University (“***KU***”) (“***Program***”), I, _____ (“***Supervisor***”), as the supervisor of him/her in the university which he/she belongs to (“***University***”), agree the following terms and conditions.

1. I agree that the Student participates in the Program and performs research activities under it (“***Research Activities***”).
2. I agree that at any time the Student will follow:
 - a) any instruction of his/her host researcher in CiRA (“***Host Researcher***”);
 - b) the bylaws, regulations and rules of KU and CiRA; and
 - c) laws and regulations, ordinances, official circular notices, guidelines and policies.
3. I agree that inventions and the like obtained from the Research Activities shall be treated in accordance with “Kyoto University’s Regulations on Inventions”, and that KU will own any findings in any form, including without limitation, resulting patent application or patent covering the same, generated by the Student during the Program.
4. I agree that any tangible materials generated under the Research Activities:
 - a) shall be treated in accordance with “Kyoto University’s Regulations on the Treatment of Tangible Results of Researchers”;
 - b) shall be vested in KU;
 - c) shall not be released or taken out of research space of CiRA without prior written approval of CiRA; and
 - d) shall not be used for any other purpose except the Research Activities in CiRA without prior written approval of CiRA.
5. I agree that any tangible materials which have already been owned by KU since before the Student participates in the Research Activities:
 - a) shall not be released or taken out of the research space of CiRA without prior written approval from CiRA; and
 - b) shall not be used for any other purpose except the Research Activities in CiRA without prior written approval of CiRA.
6. I agree that any information that the Student may access to during his/her stay in KU:
 - a) shall not be used for any other purpose except the Research Activities in CiRA without prior permission of CiRA before such information becomes in the public domain; and
 - b) disclosed and/or leaked to any third parties (including but not limited to other researchers and students in the University and myself) without prior permission of CiRA before such

Information becomes in public domain.

7. I agree that, upon termination of the Program or request from CiRA, at CiRA's direction, the Student shall return or destroy all confidential information retained in any form, including but not limited to, lab notebooks, electronic media, hard copies and duplicated papers, which are disclosed, made available or accessible by KU to the Student during the Program.
8. I agree that the Student shall not disclose and/or use any idea, research process, and/or research results that he/she may be informed of in KU from other researcher(s) without prior permission of the other researcher(s).
9. I agree that:
 - a) KU, and their directors, officers, employees and agents shall not be liable for any loss, claim, damage, or liability of any kind (including death, injury, or illness) involving the University, the Student, myself or its/his/her/my property in the course of, arising out of or in connection with the Program and/or the Research Activities whether they occur outside or inside of KU except to the extent that it is directly due to the gross negligence or willful misconduct of any of the directors, officers, employees and/or agents of KU.
 - b) the Program and/or the Research Activities are understood to be experimental in nature, and, except that KU takes the safety measures according to its internal rules to its facilities and research environment where the Program and the Research Activities are carried out, KU makes no other representations or warranties of any kind, including without limitations, any warranty of fitness for a particular purpose thereof, the quality thereof (including the accuracy, usefulness, correctness or harmlessness of the performance thereof), the non-toxicity or safety thereof, the non-existence of any defect therein, or non-infringement.
10. I agree that no rights or licenses to patent rights, copyrights, trademarks or other intellectual property rights are assigned or granted, explicitly, implicitly or otherwise, by KU to the University and/or me under or pursuant to this agreement or the Student's participation in the Program.
11. I agree that the travelling expenses and the accommodation fees for the participation of the Student covered by KU will be limited in extent within the regulations of KU.
12. Paragraphs 3, 4, 5, 6, 7, 8, 9 and 10 shall survive termination of the Program.
